











Share of Renewable Energy in Total Installed Captive Power Capacity (MW) at JK Lakshmi Cement and UCWL




Share of Green Energy in Total Power Requirement (%) *







Revenue Growth – (Nine Months ended 31.12.2024)
















Debt Profile





Standalone Debt Profile


